STATEMENT FROM THE ZUG-RAAN BAWKU NABA, ASIGRI ABUGRAGO AZOKA II, ON THE MEDIATION REPORT PRESENTED BY HIS MAJESTY OTUMFUO OSEI TUTU II, ASANTEHENE ON 16TH DECEMBER, 2025 AND THE OFFICIAL GOVERNMENT STATEMENT ON THE BAWKU CONFLICT

Otumfuo's acceptance of the role of a mediator and his more than two-years of engagements between the Bawku Naba and the Nayiri, which culminated in the submission of his final mediation report to His Excellency, President John Dramani Mahama, on December 16, 2025, is a testament to his extraordinary leadership and service not only to Asanteman but to Ghana as a whole.

In this respect, the Zug-Raan gratefully and respectfully acknowledges and fully accepts the Government's position on the Otumfuo Mediation Report.

1. In the light of the Government's position on the Otumfuo Mediation report aimed at fostering sustainable peace through reconciliation, the Zug-Raan earnestly appeals to his

- 2. The Zug-Raan appeals to all citizens and ethnic communities residing in Bawku and indeed, Kusaas and Mamprusis across the country and beyond, to unite and pursue the path of reconciliation for progress and development.
- 3. The Zug-Raan is especially pleased with the government's dedication to Bawku's socioeconomic re-development and rehabilitation. The Government's commitment to create a
 One Billion Ghana Cedis (GHS 1,000,000,000) Bawku Revitalisation Fund is certainly
 positive news for the residents of Bawku and Kusaug as a whole. The Zug-Raan expresses
 gratitude for the Revitalisation Fund. The Zug-Raan pledges to back every effort aimed at
 revitalisation and social reintegration in the Kusaug Traditional area.
- 4. His Majesty urges the people of Kusuag to pray for and commemorate all who perished in the violent conflicts, and to recommit to peaceful coexistence, ensuring that violent destruction do not occur again.
